- (c) the credit information I gave you is inaccurate.

In the event that you come to the opinion that any of the preceding conditions exist, you will give notice of same to me at the address shown for me on the application and all your obligations in respect of the transaction shall end. Once I have remedied the conditions stated in the notice to your satisfaction, you may choose to proceed with the transaction at your option.

5. I hereby authorize and direct you to disburse funds in the following manner:

- (a) to pay your fees;
- (b) to pay any existing mortgage, charge, lien or encumbrance in full as agreed by us;
- (c) to deposit any net proceeds of the mortgage loan to my account # _____ or to make available to my line of credit account, credit to the amount of allowed limit.
