In 2016, League Savings and Mortgage (LSM) introduced our new statement format. With this new format, you are able to view your transactions as well as a summary of your accounts online. It also provides you with quick easy access to RRSP Official Receipts, T4RSPs, T4RIFs, and T5s for the year. You can eliminate your paper statement and use MemberDirect® to check your balance, interest rate, and maturity date online.

Effective March 1st, 2017, LSM will no longer issue confirmation letters. Our new statement format will allow customers to view updates monthly!

I have access to a computer with an Internet connection and have the ability to view my statements in electronic form.

I acknowledge all statements posted to MemberDirect® will be in Portable Document Format (PDF), and that I am responsible for having the Adobe Acrobat Reader software required to view them. It is available free of charge from Adobe's website at www.adobe.com.

I acknowledge that I may request a paper copy of any statement normally delivered electronically by contacting LSM. I further acknowledge that my request of a paper copy of a statement does not constitute revocation of this "Consent to Electronic Delivery of Statements".

I understand that I am not required to consent to electronic delivery of statements and that by electing electronic delivery I will no longer receive them on paper by regular mail.

I understand that my consent may be revoked or changed at any time by notifying LSM. This consent shall become effective immediately upon receipt by LSM.
